II. NO TRANSFER OF OWNERSHIP:

The copyright in the Submission (**Short-Article/Article/Research Paper/Case Comment/Book Review**) shall remain with the Author, and nothing in this Agreement shall be interpreted as transfer of ownership of copyright to the 'Doon Journal of Multidisciplinary Research'.

III. LICENCE TO THE DOON JOURNAL OF MULTIDISCIPLINARY RESEARCH (ISSN (O): 2583-2581):

The Author grants to the Journal (Doon Journal of Multidisciplinary Research), an irrevocable, non-exclusive, royalty-free and transferable license to publish,

reproduce, store, transmit, display and distribute the **(Short-Article/Article/Research Paper/Case Comment/Book Review)** in the Journal or books or in any and all other media, retrieval systems, anti-plagiarism software and other formats now or hereafter known. The licence grant shall be on the following terms:
